

Carl Junction Circle of Honor - Alumni

The Carl Junction Educational Foundation proudly recognizes distinguished alumni through the Carl Junction Circle of Honor. This prestigious award celebrates Carl Junction High School graduates or one of its consolidated high schools who have achieved excellence in their academic, career, or community endeavors.

Eligibility:

1. Nominees must have graduated at least 15 years before their nomination.
2. Achievements may have occurred outside the Carl Junction area, and nominees are not required to reside within the district.
3. Posthumous nominations are welcome.
4. The following individuals are not eligible for nomination:
 - Current Carl Junction Educational Foundation members, Nominating and Selection Committee members, Carl Junction Schools Board of Education members, or Carl Junction Schools employees.
 - Former Carl Junction Schools employees who have provided compensated services within the past three years.

Nomination Requirements: Each nomination must include the following:

1. **Nomination Form** – Available as a Google Form or hard copy. Please explain the nominee's accomplishments, awards, and contributions to their field of expertise and community, highlighting a lifetime of achievement.
2. **Resume (optional)** – A professional resume may be attached to provide additional context.
3. **Letters of Support** – Two to four letters are recommended, showcasing how the nominee exemplifies leadership, character, dedication to their profession, life pursuits, and commitment to Carl Junction Schools.

Submission Deadlines and Instructions:

Nominations may be submitted at any time. Submissions can be made in the following ways:

- **Electronically:** Complete the Google Form and upload any resumes and Letters of Support as prompted.
- **By Email:** Download and complete the hard-copy nomination form, then scan and email it with any additional materials to tskaggs@cjr1.org.
